### **TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT**

- 1. The appointment is purely on contractual basis for a period of one year or till such time the alternate arrangements are made (whichever is earlier) with effect from the date of joining. This contractual appointment can further be extended for one more year, as per function requirement of the Institute, with the approval of Competent Authority. However, the contractual appointment shall not be extended beyond the period of two years under any circumstances. If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason. Contractual appointment can also be terminated at any time after joining within a period of three months, in case performance of the selected candidate is found to be unsatisfactory by the competent authority.
- 2. The consolidated remuneration for the post of Medical Physicist will be <u>Rs.1,20,000</u>/- per month (consolidated).
- The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to
  assign any duty, as and when required. No extra/additional allowances/perks will be admissible in case of such
  assignment.
- 4. The appointee shall not be entitled to any benefit like Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the institute's employees appointed on regular basis.

- 6. The appointee shall be on the whole time appointment of the Dr.RMLIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
- 7. Selected candidates will undergo medical examination by a medical board of the institute. The appointment to the said post will be subject to one being found medically fit by this medical board.

- 9. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
- 10. Other conditions of service will be governed by relevant rules and orders issued by the Institute from time to time.

# Pre-employment Medical examination

No candidate will be permitted to join the post, unless declared medically fit by the Medical Board constituted by the Institute for this purpose. The decision of the Board shall be final.
