- A Post Graduate qualification i.e Master's Degree in Physics with Post Graduate Diploma in Radiological Physics / Medical Physics or Master's Degree in Medical Physics.
- A Doctorate Degree from a recognised university.
- Three years Teaching and / or research experience in the discipline / subject concerned after obtaining the Doctorate Degree.

**Upper Age Limit and Age Relaxation**

Upper age limit & age relaxation: - 50 years as on last date of submission of application. Age relaxation as per applicable rules of Uttar Pradesh Govt.

**Note :** Candidates who have retired including voluntary retirement from Govt./semi-Govt./Govt. Corporate bodies may also apply against the said posts and his/her maximum age will be considered upto 64 years.

### **TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT**

1. The appointment is purely on contractual basis for a period of one year or till such time the alternate arrangements are made (whichever is earlier) with effect from the date of joining. This contractual appointment can further be extended for one more year, as per function requirement of the Institute, with the approval of Competent Authority. However, the contractual appointment shall not be extended **beyond the period of two years under any circumstances.** If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason. Contractual appointment **can also be terminated at any time after joining within a period of three months, in case performance of the selected candidate is found to be unsatisfactory by the competent authority.**
2. The consolidated remuneration for the post of Medical Physicist will be **Rs.1,20,000/-** per month (consolidated).
3. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty, as and when required. No extra/additional allowances/perks will be admissible in case of such assignment.
4. The appointee shall not be entitled to any benefit like Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the institute's employees appointed on regular basis.
5. The appointee shall not be granted any claim or right for regular appointment to any post of Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow.
6. The appointee shall be on the whole time appointment of the Dr.RMLIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
7. Selected candidates will undergo medical examination by a medical board of the institute. The appointment to the said post will be subject to one being found medically fit by this medical board.
8. **Leave entitlement of the appointee shall be governed in terms of instructions contained in DoPT&T's O.M. No.12016/3/84-Estt. (L) dated the 12th April, 1985 as amended by OM No. 12016/1/96-Estt(L) dated the 5th July, 1990 and further amended time to time.**



9. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
10. Other conditions of service will be governed by relevant rules and orders issued by the Institute from time to time.

### **Pre-employment Medical examination**

No candidate will be permitted to join the post, unless declared medically fit by the Medical Board constituted by the Institute for this purpose. The decision of the Board shall be final. With holding information about current or past illness /treatment if discovered at a subsequent stage may result in appropriate disciplinary action that may include termination of appointment at any stage.

### **MISCELLANEOUS INSTRUCTIONS**

- Only Indian nationals need to apply.
- The above vacancies is provisional. The Director of the Institute reserves the right to make any changes in the vacancies including reserved vacancies.
- 'No Objection Certificate' from the current employer is mandatory at the time of interview/joining (when applicable).
- The applicants, who do not have requisite qualification up to the last date for submission of application, will not be considered and will be summarily rejected.
- Canvassing of any kind will be a disqualification.
- The candidate should not have been convicted by any Court of Law.
- The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
