Governor of Uttar Pradesh (here in after referred to as “Government” of the Second Part.

**WHEAREAS FIRST PARTY has applied for admission to course and
FIRST PARTY has been selected to the said course. As per the Prospectus, the FIRST PARTY has
agreed to serve the Government for a period not less than two year after successful completion of
the course. If the FIRST PARTY fails to serve the government for a period of two
year the FIRST PARTY shall forthwith pay a sum of Rs. 10 Lacs to Government at the specified
Government Treasury. During the above period the **FIRST PARTY shall be paid Stipend, and the
Government will request their services within a period of three months from the date of successful
completion of the** MBBS course. In case the Government does not provide services in mentioned
period, the BOND shall be released; AND WHEREAS the FIRST PARTY has also agreed that on
successful completion of the MBBS Course his/her certificates relating to Course will

This bond shall in all respects be governed by the Laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.

Now This deed of Agreement Bond witnesses as follows:-

1. The FIRST PARTY has agreed to serve the Government for a period of two year on successful completion of the specialty course, MBBS course. If the FIRST PARTY fails to serve the Government for a period of two year, FIRST PARTY shall pay forthwith a sum of Rs. 10 Lac (Rupees Ten Lac only) to the Government in the specified Government Treasury.
