With reference to your application for starting of M.Ch.(Urology) Course (2 seats) and M.Ch (Surgical Gastroenterology) Course (2 seats) for the academic year 2017-18 and MCI recommendation dated 27.04.2017, I am directed to say that the Supreme Court mandated Oversight Committee (OC) vide its letter No.OC/SS-UG/2017 – 18/242 – A1 dated 14.05.2017 has conveyed its approval for starting of M.Ch. (Urology) Course and M.Ch (Surgical Gastroenterology) Course for the academic year 2017-18 at Dr Ram Manohar Lohiya Institute of Medical Sciences, Lucknow subject to the following condition:

- i. The applicant shall submit to MHFW within 15 days of issue of notification of approval by MHFW u/s 10 A (4) of IMC Act, 1956, the following
 - a) An undertaking affirming fulfillment of all deficiencies and statement made in the compliance report submitted to MCI/MHFW which are signed by Chief Secretary/ Health Secretary of the State
 - b) MHFW may thereafter at any time in 2017-18, direct inspection to verify the compliance submitted by the college, and
 - c) In default of the conditions (a) and (b) in para above, and if the compliances are found incomplete in the inspection to be conducted at instances of MHFW, the college will be debarred from fresh intake of students for 2 years commencing 2018-19.

Accordingly, I am directed to convey the permission of the Central Govt. for starting/increase of seats in the following Postgraduate (Super Speciality) course(s) with intake of students mentioned against each below with prospective effect i.e. from the academic year 2017-18 at Dr. Ram Manohar Lohiya Institute of Medical Sciences, Lucknow u/s 10A of IMC Act, 1956 subject to the conditions indicated in para(1) above.
