

**Steps of Admission (2024)**  
**(For MD/MS/DNB/MDS candidates)**

**Things to be ensured before reporting at center:**

**For RMLIMS candidates:**

1. Fill the admission form online on link <https://forms.gle/dK9HzvoHc4rVxYALA> as essential process.
2. Candidates are advised to come prepared with bond/affidavit.
3. The students reporting at the time of admission should bring all original educational certificates along with 1 set of self-attested copies.

**For Non-RMLIMS candidates:**

1. Fill the admission form online on link <https://forms.gle/2ZBzXz7NZukZbiVL8> as essential process.
2. The students reporting at the time of admission should bring all original educational certificates along with 1 set of self-attested copies.

**At reporting center: (Reporting Time: 09:30 AM to 4 PM)**

**Before 10:30 AM**

1. Report at PG cell, 1<sup>st</sup> floor, RMLIMS Academic block
2. Deposit medical fee (Rs 1000) in account section (applicable for all candidates) & admission fee (Rs 62,800; valid for RMLIMS candidates only) through online mode only.
3. Get a computer-generated slip for medical examination
4. Blood & urine samples shall be taken/deposited at a special counter adjacent to PG cell
5. Get document holding certificate following document verification & online upload on MCC (for AIQ/UPNEET portal (for state quota.)

Admission order shall be released only after submission of medical fitness certificate by the candidate.

**Important Instructions**

1. Online verification on MCC/DGME Portal
2. Document holding certificate.
3. The candidate shall be given for admission order only after submission of medical fitness certificate.
4. Request for Hostel allotment is to be given at 1<sup>st</sup> floor, SC Roy Hostel, for Admin Block.

## FAQ

- 1 Can we come prepared with service bond?  
Ans Yes. We encourage the candidates to come prepared with service bond. However, the language of the bond must be same as prescribed on website.
- 2 Can we get our bond/affidavits prepared near RMLIMS?  
Ans Yes
- 3 What is the salary provided to JR/SRs at RMLIMS?  
Ans Emoluments-Kindly refer to PG Rules version-1, available at RMLIMS website.  
Disclaimer- information is as per existing rules & regulation & subject to change as per institute's /government rules.
- 4 Is NOC mandatory for working candidates?  
Ans Yes
- 5 I don't have migration/degree at present. can I take admission?  
Ans Yes, you have to fill an undertaking at PG Cell RMLIMS that you will submit it as early as possible.
- 6 Is my seat upgradable in next counselling?  
Ans RMLIMS is accountable for admission process only. Counselling rules are beyond our scope. Kindly follow the instructions of counselling Authority. Upgradation is ticked on online verification portal subject to consent of the student.
- 7 What is the admission fee at RMLIMS & how to submit?  
Ans Admission fee is Rs 62,800 to be submitted in Account Section through online mode only.
- 8 How many days it will take to complete admission process?  
Ans Kindly keep a margin of at least two working day as medical certification/blood reporting takes time. **However, students are advised to report before 10.30 AM to make the admission process hassle free and to get finished in time.**
- 9 Can I get admission on weekends/holidays?  
Ans Since the OPDs are closed at 01 PM on Saturday, the medical fitness certification is possible on next working day only. Hence, unless it is the last day of admission, the candidates are advised to report on working days only to get a hassle-free process.
- 10 How much time will it take in admission process ?  
Ans Reporting at MCC/DGME portal is done on the same day after deposition of the prescribed fee & the required original documents. However, medical fitness is time taking so we advise the candidates to keep a margin of one day in addition to the day of reporting.  
The admission order can be issued only after deposition of medical fitness certificate.

WHEREAS FIRST PARTY has applied for admission to \_\_\_\_\_ course and FIRST PARTY has been selected to the said course. As per the Prospectus, the FIRST PARTY has agreed to serve the Government for a period not less than two years after successful completion of the \_\_\_\_\_ course. If the FIRST PARTY fails to serve the government for a period of two years the FIRST PARTY shall forthwith pay a sum of Rs 40,00,000 (Rupees Forty lakhs only) to Government at the specified Government Treasury. During the above period the FIRST PARTY shall be paid Stipend and the Government will request their services within a period of three months from the date of successful completion of the \_\_\_\_\_ course. In case the Government does not provide services in mentioned period, the BOND shall be released; AND WHEREAS the FIRST PARTY has also agreed that on successful completion of the \_\_\_\_\_ course his/her certificates relating to \_\_\_\_\_ course will not be given to the FIRST PARTY unless the FIRST PARTY successfully serves the government for a period of two years or pay to the Government on demand the sum of Rs 40,00,000 (Rupees Forty Lakhs) only.

If the FIRST PARTY fails to deposit the aforesaid amount in specified period, FIRST PARTY shall be liable to pay interest at the rates specified by the Government as per applicable law during the period of delay:

AND WHEREAS the Government have, at the request of the FIRST PARTY \_\_\_\_\_ employed as \_\_\_\_\_ granted stipend to him/her for a period of .....years with effect from \_\_\_\_\_ in order to enable his/her to study at \_\_\_\_\_ college.

This bond shall in all respects be governed by the Laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.

NOW THIS DEED OF AGREEMENT BOND WITNESSES AS FOLLOWS:-

1- The FIRST PARTY has agreed to serve the Government for a period of two years on successful completion of the \_\_\_\_\_ Super speciality course DM/MCH/\_\_\_\_\_ Post Graduate Degree MD/MS/Diploma/MDS/Graduate Degree MBBS/BDS course. If the FIRST Party fails to serve the Government for a period of two years, FIRST PARTY shall pay forthwith a sum of Rs.40,00,000 (Rupees Forty Lakhs only) to the Government in the specified Government Treasury.

2- The FIRST PARTY agrees that till the successful completion of the period of two year sservice to the Government or till the payment of Rs 40,00,000RupeesForty Lakhs only is paid the certificates relating to\_\_\_\_\_ Super Speciality course DM/MCH/\_\_\_\_\_ Post Graduate Degree MD/MS/Diploma/MDS/Graduate Degree MBBS/BDS course shall be in the custody of the Concerned Institution/University/College and the Government has a first lien over all the certificates gained by the candidates at the time of admission.

3- The FIRST PARTY authorizes the Concerned Institution/University/College for retention of the certificates till the lien of Government is cleared/discharged.

4- This BOND shall in all respect be governed by the Laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.

5- If the FIRST PARTY fails to deposit the aforesaid amount in specified period, FIRST PARTY shall be liable to pay interest at the rate specified by the Government as per applicable law during the period of delay, failing which Government shall have right to recover the aforesaid amount together with interest as arrear of land revenue.

All the candidates will have to submit following affidavits duly notarized by notary in **10 Rs Stamp Paper** each as under:-

**Affidavit No.1 (10 Rs Stamp Paper)**

- i. The candidate has been fully explained during counseling that the Medical Council of India has given permission to start.....course at Dr Ram Manohar Lohia Institute of Medical Sciences, Lucknow, which he/she has chosen to join. The course is permitted and not yet recognized by MCI.
- ii. The candidate will be given certificate of MCI recognized degree after the course is duly recognized by the MCI. In the event of the seat not getting recognized by MCI, Dr Ram Manohar Lohia Institute of Medical Sciences will not be responsible or liable for any claim.

**Affidavit No.2 (10 Rs Stamp Paper)**

- i. That I will not take part in any strike/ragging/undesired activities. In case I am found to have taken part in such activities, the Institute administration shall be free to take suitable action against me including expulsion.
- ii. I will wear the white apron bearing my name-plate as prescribed during Hospital duty hours and will follow all the rules and regulations of the institute.
- iii. I will accept the schedule of as decided by the university in accordance with the regulation of Medical Council of India and shall abide by the same.
- iv. I will not do anything which is unbecoming for a medical student vis-a vis a medical professional which may lower the prestige of Dr. Ram Manohar Lohia Institute of Medical Sciences, Vibhuti Khand, Gomti Nagar, Lucknow, or that of the medical ethics.
- v. I have been fully explained about the Bond condition, Fee structure & refund rules, in case I cancel my admission in subsequent counseling's, I do not have any objection to these conditions.
- vi. I have been fully explained that in case of any of the certificates submitted by me are found to be fake, or any deviation in format of "Bond of Rs five lakh fine& refund of stipend till the date of resignation" is caught later by the college authorities, my admission will be cancelled automatically by the institute authorities.
- vii. I have been explained that, the decisions of the Director/Dean, Dr. Ram Manohar Lohia Institute of Medical sciences, Gomti Nagar Lucknow will be final in any matter and I will be bound to follow all the decisions.
