



ANTI-REGGING COMMITTEE REPORT

1. Details of investigations done by Anti-Ragging Committee Members.

i). On receiving the complaint the Anti Ragging Committee members immediately started the investigation in the matter and interviewed the suspected students and victim as well some observers.

During investigation it was brought to notice of the Committee members that an incidence of ragging was committed by students of 2019 batch which occurred on 24.07.2021 at 02.00 PM in LT-4. Members of the Committee interviewed the suspected students of 2019 MBBS batch and some students of 2020 MBBS batch. Members of the Committee also checked their whatsapp chats & an audio clip of the alleged incidence.

After interviewing some students, checking their whatsapp chats and audio clip and investigation the suspected students involved in the alleged incidence of ragging, it was confirmed that some students were actively involved in the incidence of ragging. The committee found confirmed evidence that they have used abusive language for a girl student of 2020 batch. The following students of MBBS 2019 batch were found to be involved in the said incidence.

Committee also found that several students of 2019 MBBS batch were present at the time of incidence there and did not do anything to prevent the activity.

A representation was given by the students of 2019 batch who were incriminated in the given act of ragging their juniors of 2020 batch. All the students accepted that the meeting which was summoned in LT-4 on 24 July'2021 was unofficial and illegal and was attended by most of 2019 batch. This kind of activity within the college premises amounts to proven act of ragging.
